AGREEMENT

THIS AGREEMENT, made and entered into this 5th day of December, 1955, by and between LEE OLINGER and BLANCHE OLINGER, husband and wife, of Eureka, county of Eureka, state of Nevada, parties of the first part, and JOSEPH TOGNETTI, of the same place, party of the second part.

WITNESSETH:

The parties of the first part and the party of the second part in consideration of the promises, covenants to be kept and performed by both parties, and the mutual benefits to be derived by both parties, hereby covenant and agree with each other as follows, to-wit:

The party of the second part covenants and agrees with the parties of the first part, to make, execute and deliver to the parties of the first part, a good and sufficient deed

Conveying title to that certain portion and parcel of land maming the Lincoln Hetel Sewer System, as Grantee; said portion and parcel of land new being swned by the party of the second part in the town of Eureka, Nevada, where the present sewer disposal unit for the Lincoln Hatel Sewer System is now situated and said portion and parcel of land so conveyed is hereinafter bounded and described as follows, to-wit:

A pertion and parcel of land at Eureka, Nevada, approximately one hundred (100) feet square, and located at the south end of that certain property now owned by Jee Tognatti, where the Lincoln Hotel SewerDisposal plant is now located and being located in the SEASEA, Sec. 2; NEANEA, Sec. 11, NEANEA S 14 T. 19, Range 53 E, which is the description of the said Jee Tognetti property at Eureka, Nevada.

It is Agreed and Understood between the parties that said partian and parcel of land so conveyed shall be used exclusively for sewage disposal, and for no other purposes.

It is further Agreed and Understood that in consideration of the party of the second part conveying said portion and parcel of land unto the parties of the first part, that the said parties hereby covenant and agree as follows, torwit:

It is Agreed and Understood between the parties that in the event of a sale of the Lincoln Hotel Sewer System, by parties of the first part, then, and in that event, the parties of the first part will pay to the party of the second part, the sum of Ten (10%) percent of the purchase price monies received from the sale of said Sewer System.

It is further Agreed and Understood that after the parties of the first part have received back those sums of money expended in constructing said Lincoln Hotel Sewer System, then, and in that event, the said party of the second part shall be entitled to and receive Ten (10%) percent interest of all Net Profit Monies received from the operation of the said Lincoln Hotel Sewer System, which shall be paid in consideration of said party of the second part doing maintenance and repair work on said sewer system.

It is further Agreed and Understood that so long as parties of the first part exercise control and operation of said Bewer System that thesaid party of the second part shall have the right and privilege, so long as he is willing and able, to make connections for business houses and individual citizens desiring to keep up with said Sewer System, at a hourly or daily wage acceptable under the plumbing code.

This Agreement shall be binding upon and inure to the benefit of the heirs, administrators, successors and assigns of the parties hereto.
