Dollars, receipt whereof is acknowledged, does hereby grant and convey unto Grantee, its successors and assigns, subject to the conditions hereinafter expressed, an easement and right of way for public highway or street over, upon and across the following described land, situated in the County of Eureka, State of Nevada, to wit:

Highway Route 577 mentioned above; thence North Five Degrees Twenty-one Minutes Thirteen Seconds West (N.5°21'13"W.) a distance of Seven Hundred Forty-nine and 03/100 (749.03) feet to a point; thence from a tangent which bears the last described course, curving to the left with a radius of One Thousand Nine Hundred and 00/100 (1900.00) feet, through an angle of Fifteen Degrees Thirty-eight Minutes Twenty Seconds (15°38'20"), an arc distance of Five Hundred Eighteen and 60/100 (518.60) feet to a point; thence North Twenty Degrees Fiftynine Minutes Thirty-three Seconds West (N. 20°59'33 W.) a distance of Five Hundred and 95/100 (500.95) feet to an intersection with the westerly boundary of said Section Thirty-one (31); thence North No Degrees Forty Minutes Two Seconds East (N.0°40'02"E.) along said westerly boundary, a distance of Nine Hundred Twenty-five and 39/100 (925.39) feet to the east quarter-section corner of Section Thirty-six (36), Township Thirty-two (32) North, Range Fifty-one (51) East, Mount Diablo Base and Meridian; thence North No Degrees Sixteen Minutes Twenty-nine Seconds West (N.0°16'29"W.) along the Westerly boundary of said Section Thirty-one (31), a distance of Two Hundred Seventy-one and 73/100 (271.73) feet to a point that is left or westerly One Hundred and 00/100 (100.00) feet when measured at a right angle from that certain line surveyed for the center of Highway Route 577 mentioned above; thence from a tangent which bears North Thirty-one Degrees Fifty-nine Minutes Ten Seconds East (M.31°59'10"E.) curving to the right with a radius of One Thousand One Hundred and 00/100 (1100.00) feet, through an angle of Six Degrees Twelve Minutes Fifty-seven Seconds (6°12°57°), an arc distance of One Hundred Nineteen and 34/100 (119.34) feet to a point; thence North Thirtyeight Degrees Twelve Minutes Seven Seconds East (N.38°12'07"E.), a distance of Nine Hundred Sixty-four and 30/100 (964.30) feet to a point; thence from a tangent which bears the last described course, curving to the left with a radius of One Thousand Nine Hundred and 00/100 (1900.00) feet, through an angle of Five Degrees Eight Minutes Forty-seven Seconds (5°08°47°), an arc distance of One Hundred Seventy and 66/100 (170.66) feet, more or less, to the northerly boundary of Lot Six (6), of said Section Thirty-one (31); thence East along said northerly boundary, a distance of Two Hundred Thirty-three and 99/100 (233.99) feet to a point that is right or easterly One Hundred and 00/100 (100.00) feet when measured at a right angle from that certain line surveyed for the center of Highway Route 577 mentioned above; thence from a tangent which bears South Twenty-nine Degrees Thirtyfour Minutes Sixteen Seconds West (S.29°34'16"W.), curving to the right with a radius of Two Thousand One Hundred and 00/100 (2100.00) feet, through an angle of Eight Degrees Thirty-seven Minutes Fiftyone Seconds (8°37'51"), an arc distance of Three Hundred Sixteen and 34/100 (316.34) feet to a point; thence South Thirty-eight Degrees Twelve Minutes Seven Seconds West (S.38°12'07"W.), a distance of Nine Hundred Sixty-four and 30/100 (964.30) feet to a point; thence from a tangent which bears the last described course, curving to the left with a radius of Nine Hundred and 00/100 (900.00) feet, through an angle of Fifty-nine Degrees Eleven Minutes Forty Seconds (59°11'40"), an arc distance of Nine Hundred Twenty-nine and 82/100 (929.82) feet to a point; thence South Twenty Degrees Fifty-nine Minutes Thirtythree Seconds East (S.20°59'33"E.), a distance of Seven Hundred Thirtysix and 91/100 (736.91) feet to a point; thence from a tangent which bears the last described course, curving to the right with a radius of Two Thousand One Hundred and 00/100 (2100.00) feet, through an angle of Fifteen Degrees Thirty-eight Minutes Twenty Seconds (15°38'20"), an arc distance of Five Hundred Seventy-three and 20/100 (573.20) feet to a point; thence South Five Degrees Twenty-one Minutes Thirteen Seconds East (S.5°21'13"E), a distance of Seven Hundred Sixty-four and 43/100 (764.43) feet to an intersection with the southerly boundary of said Section Thirty-one (31); said point being distance right or easterly One Hundred and 00/100 (100.00) feet when measured at a right angle from that certain line surveyed for the center of Highway Route 577 mentioned above; thence South Eight-nine Degrees Three Minutes Twenty-seven Seconds West (S.89°03'27"W.) along said southerly boundary, a distance of One Hundred and 30/100 (100.30) feet to the point of beginning.

SUBJECT to the condition that in the event the said right of way shall be used by the Grantee for any other purpose than for that herein expressly granted, or in the event of non-user by the Grantee of said right of way for a continuous period of Two (2) years, then in either of such events the right of way hereby granted, or such part or parts thereof as shall be used for such other purposes or the use of which shall have been discontinued, shall there-upon immediately cease and determine and the right of use and possession thereof and the title thereto shall immediately revert to and revest in Grantor, its successors and assigns; provided, however, that fencing of said right of way by the Grantee so as to enclose less than the entire width herein described shall not constitute or be deemed to be a non-use or abandonment of the unfenced portion of said right of way, if the exterior boundaries thereof for the full width shall be marked by standard State Highway Department monuments.

This conveyance is subject to all contracts, leases, liens, easements and encumbrances or claims of title which may affect the lands herein described and nothing herein contained shall

be construed as a covenant against the existence of any thereof.

All of the terms, covenants and conditions hereof shall inure to the benefit of and be binding upon the successors and assigns of the parties hereto.
