The State of Nevada to the Sheriff of White Pine Greeting:

WHEREAS, on the 4th day of May, 1956 LLOYD R. GOODRICH, JR., Plaintiff recovered a Judgment in the said District Court of the Seventh Judicial District of the State of Nevada, in and for the County of White Pine, against B. U.
