NOTICE OF BREACH OF PAYMENT UPON OBLIGATIONS SECURED BY DEED  
 OF TRUST AND ELECTION TO SELL TO SATISFY OBLIGATION

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, PAUL P. NOTICE IS HEREBY GIVEN that the undersigned, as Beneficiary, has elected to consider all the principal and interest due in consequence of said default in accordance with the terms of said Promissory Note and Deed of Trust and has elected to sell or cause to be sold, said real property described in said Deed of Trust to satisfy said obligation, said sell to be made in accordance with and subject to the provisions of the laws of the State of Nevada applicable thereto.
