ORDER SETTLING FIRST AND FINAL ACCOUNT AND REPORT AND DECREE OF DISTRIBUTION

M. LEONESIO, the administratrix with the will annexed of the above entitled estate, having rendered to the court and filed herein her First and Final Account and Report and Petition for Distribution, and the same having come on regularly to be heard by the above entitled court this date, and the court having heard the same, and evidence in support of the same having been given, and no opposition thereto having been presented to the court,

NOW, THEREFORE, the court finds that due and legal notice of the hearing of said account, report and petition was given as provided by law, that said account and report is full, true, just and correct, and the same should be approved, settled and allowed in all particulars as the same was presented, and that the prayer of said petition as to the distribution of said estate should be granted as prayed for.

The court further finds that all notices and steps to be taken by the administratrix and her attorneys have been duly had and taken; that among other things, notice to creditors was duly given, as required by law, that all just debts and expenses of said decedent and of said estate have been paid; that the closing costs and the payment of the compensation of said administratrix and her attorneys, Adams & Reed, have been assumed personally by said Julia Andruss Shaw, widow and sole heir of said decedent;

And it further appearing that the estate is in a condition to be closed,

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the said first and final account and report be, and the same hereby is, approved, settled and allowed in all respects.

It further appearing to the Court that JULIA ANDRUSS SHAW is the sole heir; legatee, devisee and beneficiary of said Nelson Towne Shaw, Deceased.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED that all property of the estate of said decedent be, and the same hereby is, set over and distributed to the said JULIA ANDRUSS SHAW. That said property, so far as is know, consists of the following:

PERSONAL PROPERTY:

Certain photographic equipment situated in Washoe County, Nevada, consisting of the following: 1 - 11 X 14 photographic paper trimmer

2 - Beehive safe lights

REAL PROPERTY:

An undivided 51% in an undivided 1 interest in certain mining property situated in Eureka County, Nevada, said mine, mining ground and property being known as the Jackson Group of Mines, consisting of the "Jackson", "Wilson" and "Tinnie" claims, and known respectively as United States Government Surveys Numbers 98, 97 and 195, all located in the Eureka Mining District. Said property is presently leased to the Eureka Corporation, Ltd., under lease dated June 15, 1945 and subsequent extensions thereto, the latest extension being dated April 18, 1956. A more complete description of said mining property is attaced hereto as Exhibit "A" and hereby made a part hereof by reference.

IT IS FURTHER ORDERED, ADJUDGED AND MECREED that any afterdiscovered property belonging to the decedent not now known and which may hereafter be descovered be, and the same is hereby distributed to the said Julia Andruss Shaw.

IT IS FURTHER ORDERED that upon filing of a receipt by said Julia Andruss Shaw, as distributee, showing the delivery to her of said property, the said administratrix and her surety, The Travelers Insurance Company shall be discharged from all further responsibility herein.
