THIS PARTIAL ASSIGNMENT made this 12th day of February, 1958, by and between E. I. PUETT, First Party, and ROSS P. EARDLEY and RICHARD E. WRIGHT, Parties of the Second Part and GEORGE F. WRIGHT AND HELEN E. WRIGHT, his wife, Parties of the Thrid Part, all of Elko County, State of Nevada,

WITNESSETH:

WHEREAS, on February, 12, 1958, the Party of the First Part did receive from A.C. GRIFFITH, an assignment of an overriding royalty interest of THREE PERCENT (3%) of all oil, gas and other minerals produced and saved from the lands hereinafter described;
