PARTIAL ASSIGNMENT OF OVERRIDING ROYALTY

THIS PARTIAL ASSIGNMENT made this 12th day of February, 1958, by and between E. I. PUETT, First Party, and E. I. PUETT and JESS H. VOORHEES, Parties of the Second Part and GEORGE F. WRIGHT and HELEN E. WRIGHT, his wife, Parties of the Thrid Part, all of Elko County, State of Nevada,

WITNESSETH:

WHEREAS, on February 12, 1958, the Party of the First Part did receive from A.C. GRIFFITH, an assignment of an overriding royalty interest of THREE PER CENT (3%) of all oil, gas and other minerals produced and saved from the lands hereinafter described;

NOW, THEREFORE, in consideration of the sum of ONE DOLLAR (\$1.00), and other good and valuable consideration, received from the other parties hereto, receipt whereof is acknowledged, the First Party does hereby grant, bargain, sell and assign an undivided two-thirds ( $\frac{2}{3}$ ) interest unto the Parties of the Second Part and to their respective heirs and assigns, and an undivided one-third ( $\frac{1}{3}$ ) interest unto the Parties of the Third Part, as Tenants in Common, and not as Community Property, and to their respective heirs and assigns, that certain overriding royalty of three percent (3%) as may be obtained from the following described lands located in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

IN TWP. 30 N.R. 52 E. M.D. .&M.

Section 20: N $\frac{1}{2}$ NW $\frac{1}{4}$ ; NW $\frac{1}{4}$ NE $\frac{1}{4}$
