PARTIAL ASSIGNMENT OF OVERRIDING ROYALTY

THIS PARTIAL ASSIGNMENT made this 12th day of February, 1958, by and between E. I. Puett, First Party, and E. I. Puett and JESS H. VOORHEES, Second Parties,

WITNESSETH:

WHEREAS, on February, 12, 1958, the First Party did receive from A. C. GRIFFITH, an assignment of an overriding royalty interest of THREE PERCENT (3%) of all oil, gas and other minerals produced and saved from the lands hereinafter described;
