AGREEMENT EXTENDING TERM OF AGREEMENT  
DATED JULY 1,1957

THIS AGREEMENT made as of the 25th day of October, 1957, by and between RICHMOND-EUREKA MINING COMPANY,  
A corporation organized and existing under the laws of the State of Maine, Party of the First Part, and here-  
inafter called "Richmond-Eureka", and EUREKA CORPORATION LIMITED, corporation organized and existing under  
the laws of the Province of Nova Scotia, Dominion of Canada, Party of the Second Part, and hereinafter called  
"Eureka";

W I T N E S S E T H:

WHEREAS, by an Agreement made as of July 1,1957, the parties referred to and modified for a limited  
term certain agreements described therein and now desire to extend the term specified in said Agreement of  
July 1,1957.

NOW, THEREFORE, it is mutually agreed as follows:

1. That paragraph 4 of said Agreement made as of July 1,1957 be, and hereby is amended by deleting  
the language "October 31,1957." in said paragraph and by inserting in lieu thereof in said paragraph  
the language "April 30,1958."
2. Except as specifically provided herein, Richmond-Eureka waives no rights under said Agreement  
made as of July 1,1957 or under the Lease or the Agreement, both dated June 30,1937, with William  
F. James, as each has been amended or modified, and the said Agreement of July 1,1957 and said lease  
and said Agreement, each as heretofore and hereby modified or amended, are hereby ratified and confirmed.
