ARTICLES OF COPARTNERSHIP

ARTICLES OF AGREEMENT, made and entered into this 2nd day of January, 1956, by and between CHARLES VACCARO and SOPHIA VACCARO, husband and wife, of Eureka, county of Eureka, state of Nevada, and DONALD SAYLER and VIOLET SAYLER, husband and wife, of the same place,

W I T N E S S E T H:

That said parties above named, have joined, and by these presents do join themselves, to be copartners together, in the business of operating that certain Service Station and Garage, in Eureka, Nevada, known and referred to as "Saylers Service", and all things belonging thereto, including hauling, transfer and freight service work connected thereto, and shall continue from the 1st day of September, 1952, until a dissolution of the said copartnership between the parties.

That the name, style and title of such partnership shall be "Saylers Service", located at Eureka, Nevada.

It is agreed between the parties hereto that Charles Vaccaro and Sophia Vaccaro, have made an original investment in the total sum of Fifteen Thousand Four hundred eighty six and 60/100 (\$15,486.60) dollars, and that said Charles and Sophia Vaccaro shall be repaid one-half ( $\frac{1}{2}$ ) of such original investment, or the sum of Seven Thousand Seven Hundred Forty Three and 30/100 (\$7,743.30) dollars on or before January 1, 1953, without interest.

It is further agreed between the parties hereto that Charles Vaccaro and Sophia Vaccaro, have invested the additional sums of One Thousand Seventy One and 17/100 (\$1,071.17) dollars, which represents said parties fifty (50) percent profit from the business for the year 1953, and a further sum of Nine Hundred Ninety Three and 47/100 (\$993.47) dollars, likewise invested in said business that represents said parties profit based on six (6) percent interest on moneys invested and computed for the year 1954.

It is agreed between the parties hereto that said profits for the years 1953 and 1954, which have been reinvested in said business by Charles Vaccaro and Sophia Vaccaro, shall be repaid by said business on or before January 1, 1963, without interest.

That said Donald and Violet Sayler, for services rendered in the operations of said business, shall be entitled to draw from said business as living expenses, an amount of money not to exceed Six Thousand (\$6,000.00) dollars in each and every calender year that this copartnership shall be in existence.

That Donald Sayler and Violet Sayler have an original investment of One Hundred Fifty Five (\$155.00) Dollars for Radio Tube Inventory in said business; and it is agreed and understood between the parties that said Donald Sayler and Violet Sayler are at the date of the execution of this agreement, indebted to said business in the sum of Nineteen Hundred Sixty One and 91/100 (\$1961.91) dollars, for cash advanced from said business.

That true and correct books of accounting of the business shall be kept at all times, and that the parties to this copartnership shall share in the expenses and net profits of the business on a fifty-fifty, share and share alike basis.

That at the determination of their copartnership, the said copartners shall make a full, true and final account of all things relating to their business, and that all and every piece of property, stocks, merchandise or money, of any kind or description, shall be divided between them, share and share alike.
