8 IT IS FURTHER MUTUALLY AGREED that the said premises now under contract of sale to the Damele Brothers, shall, in the event of forfeiture, revert entirely to Charles Vaccaro and shall become his sole and exclusive property: It is further agreed that any policy of fire insurance shall be in the name of Charles Vaccaro, and any proceeds from fire loss shall become his sole and exclusive property.

IT IS AGREED that all Accounts Receivable shall, upon the payment from Charles and Sophia Vaccaro of the sum of Five Hundred Dollars, to Donald and Violet Sayler, be assigned, set over, and become the sole and exclusive property of Charles and Sophia Vaccaro.

IT IS AGREED AND UNDERSTOOD that the money now on deposit in the First National Bank of Nevada, Eureka Branch, Eureka, Nevada, shall be divided share and share alike, immediately upon the execution of this agreement.

It is agreed that this instrument shall constitute a full and complete assignment of account between the parties and that all matters concerning personal property of the copartnership or obligations owed by the said copartnership have now been fully and completely settled.
