ANGELA PLMA, whose true and correct name is ANGELA PARMIGIANI, being first duly sworn deposes and says:

That my maiden name was ANGELA MAGLIA, and that according to family records I was born at Strella, near Genoa, Province of Liguria, Italy, on July 14, 1870.

That I married ENRICO PARMIGIANI about 1891 at New York City, New York. That Enrico Parmigiani, according to my information, was born in Italy. Shortly after our marriage, Mr. Enrico Parmigiani and I went to Eureka, Eureka County, Nevada, and lived there until about 1935 when we moved to Reno, Nevada.

That on January 20, 1914 I gave birth to a daughter whose Certificate of Birth is recorded in State Index No. 67, Local Register No. 1 of Nevada State Board of Health, Bureau of Vital Statistics, and which daughter was given the name of SYLVIA PARMIGIANI, sometimes spelled PARMIGIONI: that the father of Sylvia Parmigiani was my husband, ENRICO PARMIGIANI.

That my husband worked at the Diamond Mine at PROSPECT MOUNTAIN, Eureka County, Nevada, and the foreman, for his convenience, called my husband HENRY PALMA, by which name my husband was generally known thereafter, as well as his family. That my daughter, SYLVIA PARMIGIANI, used the name of VIRGINIA SYLVIA PALMER, and she is now known as VIRGINIA SYLVIA PALMER, and she is one and the same individual referred to in the Birth Certificate of record in State Index No. 67, Local Register No. 1, of Nevada State Board of Health, Bureau of Vital Statistics, and who was born on January 20, 1914, at the Town of Eureka, County of Eureka State of Nevada.

My daughter, SYLVIA PARMIGIANI was baptised in St. Brendan's Catholic Church at Eureka, Eureka County, Nevada, about 1915, and the Godfather of my daughter was HENRY PALMA, and her Godmother was MRS. MARY VENTURINO.
