The said property consists of the following real and personal property, to-wit: All of Lots 20 in Block 7; the south 14.85 feet of Lot 19 in Block 7, together with house and improvements situate thereon, together with equipment and furnishings; one 1950 Buick sedan; one-third (1/3) interest in the Eureka Keystone and Clipper Mining Claims, in Eureka Mining Bistrict, Eureka, Nevada.
