WITNESSETH: That first party, for and in consideration of Ten and CO/100 (10.00) Dollars, receipt whereof is acknowledged, does hereby grant, bargain, sell and convey unto second party, her heirs and assigns, the
following described land situated in the County of Eureka, State of Nevada, to wit:

All of SectionsOne (1), Three (3), Eleven (11), Thireen (13), Fifteen (15), Twenty-three (23) Twenty-five (25), Twenty-seven (27) and Thirty-five (35), Township Thirty (30) North, Range Forty-nine (49) East; Also,

SAVE AND EXCEPTING THEREFROM the right to use all water naturally rising upon or flowing across said land which may be needed for the operation and repair of such railroad, and the right to conduct the same as well as water rising upon orther land, across the land herein described, in pipes or aqueducts, for the purpose aforesaid; together with all necessary rights of way therefor.

PROVIDED that no lapse of time in the exercise of the right to take and use water, or in the selection of the strips of land herein excepted or rights of way for the conduct of water, shall be deemed an abandonment of said rights or property by first party, nor a vestiture of any adverse right in second party; that second party shall erect and forever maintain good and sufficient fences on both sides of said strip or strips of land herein excepted; that the provisions contained herein shall inurseto the benefit of the successors and assigns of first party, and be binding upon second party, her successors, heirs and assigns.
