IT IS HEREBY ORDERED, ADJUDGED AND DECREED that said sale of an undivided four-fifths (4/5) interest in and to the above described property to JOHN HANDLEY HUNTER and KATHRYN HUNTER, husband and wife, be, and the same is hereby, confirmed, approved and declared in all things valid; and that proper and legal conveyances of said undivided interest in said above described property and such other legal instruments and documents, agreements or contracts as are necessary to carry out the terms of said sale are hereby ordered and directed to be executed to said Purchasers by said Executrix upon condition that the said Purchasers, as soon as the exact amount of said administration costs and taxes payable to the Federal Government become ascertained, execute and deliver to said Executrix a Promissory Note or Notes in such amount and further execute and deliver to said Executrix a Promissory Note in the sum of Ten Thousand Dollars (\$10,000.00), representing the total amount of said administration costs and taxes, and secured by a Deed of Trust on the hereinabove described real property, which said Deed of Trust shall contain a subordination clause whereby the said Purchasers will be in a position to borrow money on said real property in an amount not to exceed Twenty Five Thousand Dollars (\$25,000.00).
