ASSIGNMENT OF CONTRACT OF SALE OF REAL PROPERTY

THIS AGREEMENT, made and entered into as of the 22nd day of October, 1957, by and between, LOUIS J. BRONSTEIN, EDWARD B. FRASIER, GEORGE E. ROSS, HARRY H. MILES, DINO J. ARNOLD and MAXINE HOLMES, hereinafter referred to as "Sellers", promised to sell to Assignors, for the price and according to the terms specified in said agreement, those certain parcels of land situated in the Counties of Lander and Eureka in the State of Nevada, and more particularly described as follows, to wit:

All of Section 29, the East one-half (1/2) of Section 31 and the West one-half (1/2) of Section 33, All in Township 29 North, Range 48 East, M.D.M., Containing in all 1280 acres, more or less.

Together with a certain well and pump installed on said premises.

Subject to the reservation of gas and oil rights by the Southern Pacific Company, as appears of record.

and

Assignors having agreed and promised to transfer to Assignee all of their right, title and interest in and to said agreement, and the realty therein described, and to allow Assignee to assume Assignors obligations thereunder, as partial consideration for the sale and issuance to Assignors of Capital stock of Assignee, and

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained and of the due performances thereof, the parties do hereby bind themselves each unto the other as follows:

1. Assignors shall and do hereby assign to Assignee, and Assignee hereby consents to and accepts the assignment of all of Assignors' right, title and interest in and to that certain agreement by and between Assignors as Purchasers and Sellers hereinabove mentioned, dated the 20th day of May, 1957, and under the terms of which Assignors agreed to purchase and Sellers agreed to sell to Assignors that certain realty situated in the Counties of Lander and Eureka, State of Mevada, and more particularly described as follows:

All of Section 29, the East one-half (1/2) of Section 31 and the West one-half (1/2) of Section 33, all in Township 20 North, Range 48 East, M.D. M., containing in all 1289 acres, more or less.

Together with a certain well and pump installed on said premises.

Subject to the reservation of gas and oil rights by the Souther Pacific Company, as appears of record.

- 2. Assignors shall and hereby do assign to Assignee all of their right, title and interest in and to the real property in paragraph 1 hereof.
- 3. Assignme shall, and by these presents hereby does, assume all of Assignors liabilities and obligations under that certain agreement specified in paragraph 1 hereof.
