RIGHT-OF-WAY

For and in consideration of the sum of One Dollars (\$1.00), receipt whereof is hereby acknowledged, the undersigned, hereinafter referred to as "Grantor", hereby grant a right of way to BELL TELEPHONE COMPANY OF NEVADA, a corporation, and TOWN OF CARLIN, a municipal corporation, their successors and assigns, hereinafter referred to as "Grantees", with the right to construct, place, inspect, maintain and replace thereon poles, crossarms, wires, cables, braces, transformers, terminal boxes, service lines, fixtures, anchors and guys, and to keep the same free from any trees or any parts of trees or any foliage across that certain property situated in the County of Eureka, State of Nevada, and described as follows:

A portion of the South one-half of the Southwest one-quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 11, Township 32 North, Range 50 East, M.D.B.M.

Said right of way is ten (10) feet in width, five (5) feet on each side of the centerline as now surveyed and staked by Grantees' on said above described real property.

Grantees, their contractors, agents, employees and servants shall at all times have the right of ingress to and egress from said right of way and the poles, crossarms, wires, cables, braces, transformers, terminal boxes, service lines, fixtures, anchors and guys thereon with the specific understanding that Grantees shall be responsible for any property damage suffered by Grantor caused by Grantees' exercise of the rights herein granted.

Grantees are also granted the right from time to time to increase or decrease the size, weight or number and to change the position of the poles, crossarms, wires, cables, braces, transformers, terminal boxes, service lines, fixtures, anchors and guys which may be constructed or installed in or upon the right of way hereby granted.
