JUDGMENT AND DECREE OF DIVORCE

The above entitled action came on regularly to be heard this 20 day of July, 1959, before the Court, sitting without a jury, the Honorable John F. Sexton, presiding, upon the verified complaint of plaintiff, the plaintiff personally appearing with her attorney, Johnson W. Lloyd, Esq., and the defendant not personally appearing,

nor being represented by counsel, but having heretofore been duly and regularly served with summons at Eureka, Nevada, and the default of the defendant having been duly and regularly entered for failure to answer or otherwise plead to the complaint of plaintiff on file herein, and the Court being fully satisfied as to the sufficiency of the law and the facts in the premises, and evidence having been adduced on the part of plaintiff, and the said cause having been duly submitted to the Court for its decision and judgment, and good cause appearing therefore:

The Court having found that all of the allegations of plaintiff's complaint are true, and that by reason thereof the plaintiff is entitled to a Judgment and Decree of divorce.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED and DECREED:

That the bonds of matrimony now and heretofore existing between the plaintiff and defendant be, and the same are hereby dissolved; that the parties be, and they hereby are released from the bonds and obligations thereof, and restored to the status of single and unmarried persons.

IT IS FURTHER ORDERED, ADJUDGED and DECREED That the following described real and personal property situate in the town of Eureka, Nevada, be and the same is hereby awarded to plaintiff:

Lots five and six in Block fifty seven of the town of Eureka, Nevada, together with the frame house, sheds and improvements thereon, together with all furniture, fixtures and equipment located in the said frame house.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that the 1941 Plymouth sedan automobile; the 1932 Chevrolet Coupe automobile; Box trailer, tools or work equipment, be and the same is hereby awarded to the defendant.
