## AFFIDAVIT OF IDENTITY

HELEN VIOLA MAU KING, being first duly sworn, deposes and says:

That according to family records I was born on August 16, 1909 at the Town of Eureka, County of Eureka, State of Nevada. On February 26, 1938, I married a Mr. King and my name was then HELEN VIOLA MAU KING. I was divorced from Mr. King on July 25, 1950 and thereafter married a Mr. Cross on October 28, 1950. I was divorced from Mr. Cross on March 26, 1954 and in the decree of divorce was awarded the privilege of resuming the use of my former name of HELEN VIOLA MAU KING. This decree of divorce was granted in the City and County of San Francisco, State of California, Action No. 523-209 under date of March 26, 1954.

The name of my father was OTTO RICHARD MAU and he died July 21, 1945, in the town of Eureka, State of Nevada. My mothers name was OLGA LOUISE WILHELM MAU and she was known as Olga Louise Mau, Olga L. Mau and as Mrs. O. R. Mau. My mother died in Washoe County, Nevada, on July 1, 1959 and at the time of her death was a resident of the City of Reno, County of Washoe, State of Nevada.

Under date of November 18, 1953, Olga Louise Mau, a widow, made, executed and delivered a joint tenancy deed to Olga Louise Mau and Helen Viola Cross now Helen Viola Mau King, transferring and conveying to the parties of the second part all those certain lots, pieces ar parcels of land situate in the town of Eureka,

County of Eureka, State of Nevada, and bounded and described as follows, to-wit:

Lot 10 of Block 22; and

Lots 1, 2 and 3 of Block 91; and

The North 32 feet of Lot 10 in Block 93;

Together with all improvements on the

property above described.

Under date of November 18, 1953, OIGA LOUISE MAU, a widow, made, executed and delivered a joint tenancy deed in favor of OIGA LOUISE MAU and HELEN VIOLA CROSS, now HELEN VIOLA MAU KING, transferring and conveying parcels A, B and D of Lot 10, and all of her interest in and to parcel C of Lot 10, all in Block A of License Survey Map No. 154021, Hillbrae Addition, on file in the office of the Washoe County Recorder.

Said property is described as all those certain Lots, pieces or parcels of land situate in the County of Washoe, State of Nevada, and bounded and described as follows, to-wit:

"Parcels A, B and D of Lot:10, Block A, according to the License Survey Map No. 154021, Plat of Lot 10, Block A, Hillbrae Addition, on file in the office of the Washoe County Recorder. Together with all improvements thereon and all rights incident and appurtenant thereto.

Parcels A and D are further described in the Deed dated August 18, 1948 between FRED BENDSUS and JOHN WESLEY SHEPARD to OLGA LOUISE MAU, which Deed is recorded in Vol. 222 of Deeds, Page 211. Parcel B is further described in the Deed dated July 9, 1948 between PETER A. LIMA and STELLA MARIE LIMA to OLGA LOUISE MAU, which Deed is recorded in Vol. 220 of Deeds, Page 368.

Also all of the interest of party of the first part in and to Parcel C of Lot 10, Block A, according to the License Survey Map, No. 154021, Plat of Lot 10, Block A, Hillbrae Addition, on file in the office of the Washoe County Recorder.

Parcel C is further described in the Deed dated August 18, 1948 between FRED BENDSUS and JOHN WESLEY SHEPARD to OLGA LOUISE MAU, which deed is recorded in Vol. 222 of Deeds, Page 211."

That under date of February 24, 1948, Major D. Holby and Dorothy Holby signed and delivered their certain promissory note for \$7400.00 to D. R. Heidrich and R. L. Heidrich, which promissory note is secured by a Deed of Trust, bearing same date, signed, acknowledged and delivered by said Major D. Holby and Dorothy Holby, Trustors, to Washoe County Title Guaranty Company, Trustee, and D. R. Heidrich and R. L. Heidrich, beneficiaries, which Deed of Trust was recorded on February 26, 1948, under file No. 160938 in Book 215 of Deeds of Trust, Page 307, Records of Washoe County, Nevada. Said Deed of Trust and Promissory Note, under date of January 20, 1954, was assigned and transferred by D. R. Heidrich and R. L. Heidrich to Olga Louise Mau and Helen Viola Cross, now Helen Viola Mau King, as joint tenants, and not as tenants in common, with right of survivorship, and to the heirs and assigns of such survivor forever. Said assignment is recorded under date of January 20, 1954, File No. 224545 in Book 341 of Deeds of Trust, Page 398, records of Washoe County, Nevada. That the unpaid balance due on said Prommissory Note as of September 15, 1959 was \$3,794.05.

That under date of 30, 1955, John Upton and Claudie E. Upton, signed and delivered their certain promissory note for \$11,200.00 to Adelaide Heidrich, Ronald L. Heidrich and Margaret Heidrich, Delbert Heidrich and Phyllis Heidrich, which promissory note is secured by a Deed of Trust bearing same date and signed and acknowledged by John Upton and Claudie E. Upton, Trustors to Washoe Title Insurance Company, Trustee, and Adelaid Heidrich, a single woman, Ronald L. Heidrich and Margaret Heidrich, Delbert Heidrich and Phyllis Heidrich, beneficiaries, which Trust deed was recorded on March 30, 1955, under File No. 241396 in Book 377 of Deed so Trust, Page 277, Records of Washoe County, Nevada. Said Trust Deed and Promissory Note under date of August 26, 1957 was assigned by Adelaide Heidrich, Ronald L. Heidrich and Margaret Heidrich, Delbert R. Heidrich and Phyllis Heidrich, to Olga Louise Mau and Helen Viola Mau King, assigness, as joint tenants, and as tenants in common, with right of survivorship, and to the heirs and assigns of such survivors forever. Said assignment was recorded under date of August 26, 1957, under File No. 278301, in Book 455 of Deeds of Trust, Page 18, Records of Washoe County, Nevada. That the unpaid balance due on said Promissory Note as of September 18, 1959, was \$9,407.34.

That Olga Louise Mau, who was also known as Olga Wilhelm Mau, and Olga L. Mau and Mrs. O. R. Mau, who is named in the attached Certificate of Death, is one and the same person as Olga Louise Mau, who is named as one of the grantees in those certain joint tenancy deeds heretofore described, and as one of the assignee

beneficiaries of the assignment and promissory note, secured by Trust Deed, heretofore referred to, and she died on July 1, 1959 at the Silver Star Rest Home, Postoffice Address, Steamboat, Washoe County, Nevada, and she was a resident of the City of Reno, County of Washoe, State of Nevada, at the time of her death.
