JONES, his wife, of the same place, as joint tenants with right of survivorship and not as tenants in common, the following described personal property situate in and upon these certain premises being conveyed by the Vendors herein to the Vendees herein under an escrow deed executed under the terms of a certain agreement between the parties hereto, dated February 25, 1952, to-wit:

180 Head, more or less, of cattle, including yearlings and up. All unbranded calves to go with their mothers and uncounted.

Together with approximately 35 or 40 head of sheep.
