ORDER AND DECREE OF DETERMINATION OF TERMINATION OF  
INTEREST OF A DECEASED JOINT TENANT

The verified Petition of PIETRINA ETCHEGARAY, also known as PIETRINA MARGARET ETCHEGARAY, and LeROY WAYNE ETCHEGARAY, of the County of Eureka, State of Nevada, as the surviving joint tenants, praying to have determined the termination of the interest of their deceased joint tenant in and to certain real property situate in the Eureka, State of Nevada, filed under and by virtue of the provisions of NRS 40.470, coming on regularly to be heard on the 10th day of October, 1960, at the hour of 10:30 A. M., and the Court being satisfied that due and legal notice of the hearing of said Petition has been given as required by the applicable laws of the State of Nevada, and under the order of this Court; and the Petitioners being represented by their attorney, KENNETH L. MANN, ESQ., and no person or persons appearing to contest or object to the Petition, or the matters therein set forth, the Court, after hearing the evidence submitted in support of said Petition, finds as follows:

That during the lifetime of FRED ETCHEGARAY, the said Petitioners, PIETRINA ETCHEGARAY, also known as PIETRINA MARGARET ETCHEGARAY, and LeROY WAYNE ETCHEGARAY, acquired in joint tenancy with right of survivorship with the said FRED ETCHEGARAY, the following described real property situate in the County of Eureka, State of Nevada:

PARCEL I

The North Half of the Southeast Quarter ( $N\frac{1}{2}SE\frac{1}{4}$ ) of Section Eight (8), the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section Nine (9), and the Northeast Quarter of the Northwest Quarter ( $NE\frac{1}{4}NW\frac{1}{4}$ ) and the Northwest Quarter of the Northeast Quarter ( $NW\frac{1}{4}NE\frac{1}{4}$ ) of Section Sixteen (16), all in Township Twenty (20) North, Range 49 East, M.D.B. & M., Nevada, containing 320 acres.

TOGETHER With all buildings and improvements situate thereon or connected therewith.

TOGETHER with all buildings and improvements situate thereon or connected therewith.

TOGETHER with all water, water rights, stock-watering rights, artesian wells, troughs, pumps, tanks, pipe, pipe lines, and reservoirs connected therewith.

TOGETHER with any and all range rights appurtenant thereto.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

PARCEL II

Lots one (1), two (2), and three (3), and the Northwest Quarter of the Southeast Quarter ( $NW\frac{1}{4}SE\frac{1}{4}$ ) of Section thirty-six (36) in Township Twenty-two (22) North, Range Forty-eight (48) East, M.D.B. & M., Nevada, containing one hundred sixty and eighty-six hundredths acres, being the same land described in Federal Patent Number 729845.

TOGETHER with all buildings and improvements located on said land and all furniture and fixtures contained in the buildings thereon, and also all farm machinery, implements and tools now located on said property.

TOGETHER with all water, water rights, stock-watering rights, artesian wells, troughs, pumps, tanks, pipe, pipe-lines and reservoirs connected therewith, and particularly the following named springs: Potato Canyon Spring located in the  $SE\frac{1}{4}SW\frac{1}{4}$  of Section 26; Snow Water Canyon Spring located in the  $SE\frac{1}{4}NE\frac{1}{4}$  of Section 28; Fagin Spring located in the  $NE\frac{1}{4}NE\frac{1}{4}$  of Section 21; Cottonwood Spring No. 1 located in  $SW\frac{1}{4}SW\frac{1}{4}$  of Section 10; Cottonwood Spring No. 2 located in the  $NW\frac{1}{4}NE\frac{1}{4}$  of Section 10, all in Township 22 North, Range 48 East, M. D. B. & M.

TOGETHER with any and all range rights appurtenant thereto.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

THE COURT FURTHER FINDS that the said joint tenant, FRED ETCHEGARAY, died on or about the 4th day of February, 1960, and that said decedent, at the time of his death, was a resident of the County of Eureka, State of Nevada, and that he was over the age of twenty-one years; and that Petitioner PIETRINA ETCHEGARAY is the surviving wife of the above-named Decedent, and Petitioner LeROY WAYNE ETCHEGARAY is the surviving son of the above-named Decedent.

IT IS, THEREFORE, HEREBY ORDERED AND DECREED:

That upon the death of the said FRED ETCHEGARAY, the Petitioners herein succeeded as survivors to all the right, title, interest and estate in and to said real property of said deceased joint tenant, FRED ETCHEGARAY, in and to said real property, and the whole thereof is now vested in said PIETRINA ETCHEGARAY and LeROY WAYNE ETCHEGARAY.

IT IS FURTHER ORDERED that the surviving joint tenants, PIETRINA ETCHEGARAY and LeROY WAYNE ETCHEGARAY, file for record in the office of the County Recorder of the County of Eureka, State of Nevada, a certified copy of this Order and Decree.
