That paragraph Sixth of said "Novation and Amendment" of March 19, 1959, provided that both parties shall execute any and all instrument necessary to carrying the intentions of the parties thereinbefore stated and shall assist one another in any and all matters required by the other; that pursuant thereto, on said March 19, 1959, defendant executed and delivered to plaintiff a special irrevocable power of attorney, a copy of which is attached hereto as Exhibit "C", and by reference thereto is made a part hereof, giving plaintiff the power to Manage and control the oil and gas leases hereinbefore described for a period of seven years from the date thereof.

IV.

That, despite the fact that said special power of attorney provided that it shall continue without being revoked for a period of seven years from the date thereof, defendant executed a document dated October 13, 1959, a copy of which is attached hereto as Exhibit "D", and by reference thereto is made a part hereof, purportedly revoking and cancelling said special power of attorney; that said purported revociation of the special power of attorney has prevented plaintiff from managing, controlling or otherwise conducting the necessary activities in regard to said oil and gas leases; that, unless defendant is ordered to deliver up said purported revocation
