ORDER SETTING ASIDE ESTATE

It appearing to the satisfaction of the Court that a verified Petition has been filed and Notice of the Hearing thereon has been duly given as required by law, the Court finds that the allegations of the Petition are true and correct; that the gross value of the whole estate of said decedent does not exceed the sum of ONE THOUSAND DOLLARS (\$1,000.00); that the Petitioner, DOROTHY ALICE WIEDERSHEIM, is the surviving wife of the Decedent; that so far as known to the Petitioner the Decedent has no unpaid debts and the expenses of the last illness of said Decedent, funeral charges and expenses of administration have been paid;
