

DECLARATION OF HOMESTEAD

THIS DECLARATION OF HOMESTEAD, made this 11th day of May, 1962, by VERNON A. MANZ

AND BEVERLY MANZ, husband and wife of the Town of Eureka, County of Eureka, State of Nevada.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned VERNON A. MANZ and BEVERLY MANZ, husband and wife, at the time of making this declaration, reside in, upon and with their minor children, on the following described premises, and that it is their intention to use and claim said premises as a homestead. Said premises are situate in the Town of Eureka, County of Eureka, State of Nevada, and more particularly described as follows:

Lots 1, 2 and 3 in Block 100, lying and being in the Townsite of Eureka, County of Eureka, State of Nevada, and as the same is delineated upon the official plat of the survey of said Town Site, which is now on file in the Bureau of Land Management, Washington, D. C., all of which said lands was conveyed by the United States of America to the said W. R. Reynolds, in Trust, by patent No. 1122995, bearing date of December 1, 1947, and which is recorded in book 23 of Deeds, page 226, records of Eureka County, State of Nevada, together with all improvements thereon.

Together with all buildings of every name and nature and description situate thereon.

Together with the furniture and furnishings situate therein.

That the undersigned do further declare that their interest in said land, the dwelling house, improvements, and furniture situate thereon and its appurtenances, that is to say, their equity therein, does not exceed the value of the sum of \$10,000.00; that the undersigned have never selected any other land or dwelling house as a homestead, and that the lands, premises, dwelling house, improvements and appurtenances hereinabove particularly described is selected by the undersigned and it is their further intention that said homestead shall be held by them.
