## DECLARATION OF OWNERSHIP

NOW, THEREFORE, in consideration of said transaction and said installation upon said premises and to induce the same, Owner by these presents does hereby consent to the installation thereof upon the premises and agrees that it at all times shall remain personal property and shall not become a part of the freehold and does hereby waive and relinquish unto the Seller and Seller's heirs, successors and assigns (herein collectively referred to as "Seller") all claims and demands of every kind Owner may now or hereafter have against said equipment\*and to enter upon said premises for the purpose of inspecting the same and repossessing and removing it from said premises when Seller may elect so to do after default by the Owner in any of the terms of said transaction, without liability for damage to disconnect all water, gas, power, telephone lines and any other facilities and installations necessary to effect the removal of said equipment from the premises as aforesaid and agrees that Seller may conduct a sale of it on the premises, post notices of such sale thereon, and shall have the right to enter upon the premises for the purpose of guarding or maintaining it or preparing same for sale, and seller shall not be obligated to pay any rent or any charge for the rights herein granted.

This instrument and all the rights hereby granted to Seller shall terminate upon the satisfaction by Owner of all obligations under the transaction or upon the complete removal of the equipment from the premises, whichever is the earlier, and upon such termination, Seller shall execute and deliver to Owner a release of all of the rights granted herein.

This instrument and all covenants herein shall run with the land described herein and all the terms and provisions hereof shall bind and inure to the benefit of the respective heirs, executors, administrators, legal representatives, successors and assigns of the parties hereto and any conveyance or mortgage of the premises described herein shall be subject and subordiante to all of the terms and provisions of this instrument.
