ORDER APPOINTING GUARDIAN AND ALLOWING GUARDIAN TO  
COMPROMISE MINOR'S CLAIM

Upon reading the verified Petition for appointment of Guardian and allowing said Guardian to compromise claim of the above-named minor, TIMOTHY DEAN PALMORE, also known as TIMOTHY DEAN POWELLMORE, a minor person, filed herein on the 22nd day of June, 1962, by the Petitioner, EDWARD DELANEY, of Eureka, Nevada, and having been heard at the duly appointed time on the 25th day of June, 1962, the Court Finds the allegations of the Petition to be true, and good cause appearing therefor,

IT IS HEREBY ORDERED that Letters of Guardianship of the Estate of TIMOTHY DEAN PALMORE, also known as TIMOTHY DEAN POWELLMORE, a minor, issue to the Petitioner EDWARD DELANEY upon qualifying and taking the oath of office, and to serve without bond in that capacity; that EDWARD DELANEY upon qualifying shall execute a quitclaim deed for said minor child's interest in and to Desert Land Entry No. 055518 situate in the County of Eureka, State of Nevada, to ERNEST WIGGAINS for which said Guardian shall receive the sum of \$2,500 from ERNEST WIGGAINS and shall deliver said \$2,500 to IVA L. PALMORE of Jamul, California, the mother of the above-named minor child, after deducting all fees and costs incurred by reason of these proceedings; that said sum of \$2,500 after fees and costs are deducted shall be used by IVA L. PALMORE for the support and care of TIMOTHY DEAN PALMORE, also known as TIMOTHY DEAN POWELLMORE.

IT IS FURTHER ORDERED that PHILIP M. MARFISI, attorney for the Petitioner, receive the sum of \$250.00 for his fee for services rendered; and EDWARD DELANEY as the Guardian of said minor receive \$100.00 for services rendered in that capacity; said fees to be deducted from the \$2,500 received for said minor's interest in and to that desert land entry as described in the Petition, from ERNEST WIGGAINS of Eureka, Nevada.

IT IS FURTHER ORDERED that upon execution of the said quitclaim deed of said minor's interest in and to that desert land entry, as aforementioned, and upon the filing of the proper vouchers and receipts that such payment of funds has been completed, and that the balance of said funds be transferred to IVA L. PALMORE, the mother of the above-named minor child; that EDWARD DELANEY, as Guardian of the Estate of TIMOTHY DEAN PALMORE, also known as TIMOTHY DEAN POWELLMORE, a minor, shall be discharged from further duties and services as Guardian thereof.
