DECREE SETTLING FIRST AND FINAL ACCOUNT
AND PETITION FOR DISTRIBUTION

ERNEST O. BAUMANN, and WALTER E. BAUMANN, Executors of the Last Will and Testament of the above-named Decedent, having on the 8th day of July, 1959, rendered and filed herein a full account and report of the administration of said Estate, which said Account was for a final settlement, and having with said account filed a Petition for the final distribution of said Estate, and hearing on said Account and Petition having been set for the 20th day of July, 1959, at 10:00 o'clock A.A., and having come on at such time and proof having been made to the satisfaction of the Court that the due and legal notice of settlement of said account and the hearing of said Petition for Distribution had been given as required by law, the Court hereby finds:

That the said First and Final Account is in all respects true and correct; that it is supported by proper vouchers; that the residue of money in the hands of the Executors at

the time of hearing the said account was \$24,119.82.

That due and legal notice to creditors of the said Estate has been given for the time and in the manner required by law. That there were no Creditor's Claims filed against the above-named Estate.

That all taxes of every name and nature required to be paid by Decedent's Estate have been paid.

That CHARLES B. EVANS, JR. advanced costs of administration in the sum of \$10.00, which have not been repaid. That CHARLES B. EVANS, JR., Attorney for said Estate is entitled to the allowance of the payment of a reasonable attorney fee in the amount of \$6636.00.

That JOHNSON W. LLOYD, as Attorney for the absent heirs, is entitled to a reasonable attorney fee in the amount of \$1700.00.

That the said Petitioners are entitled to the allowance and payment of statutory fees and commissions for services as Executors of said Estate.

That EMIL WALTI, DAN FILIPPINI and EARL GREEN have acted as appraisers for said Estate, and a reasonable fee to be paid to them would be \$75.00 to EMIL WALTI, \$50.00 to DAN FILIPPINI, and \$65.00 to EARL GREEN.

That said Estate is in all respects ready to be closed.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

That due and legal notice of the hearing of said First and Final Account and Petition for Distribution was given as required by law and the order of this Court. That the First and Final Account and Petition for Distribution of said Executors be and the same hereby is finally settled, allowed and approved.

That due and legal notice to creditors of said Estate was given in the manner and for the time required by law.

That CHARLES B. EVANS, JR., Attorney for said Estate advanced the sum of \$10.00 as costs of administration of said Estate and that the sum of \$6636.00 is a reasonable fee for the said CHARLES B. EVANS, JR., Attorney for said Estate, for his services to said Estate; that the same be paid unto him. That the sum of \$1700.00 is a reasonable fee for JOHNSON W.
