RIGHT OF WAY GRANT

For and in consideration of the sum of One Dollar (\$1.00), receipt whereof is hereby acknowledged, the undersigned, hereinafter referred to as "Grantors", hereby grants to SIERRA PACIFIC POWER COMPANY, a Corporation, its successors and assigns, hereinafter referred to as "Grantee", a right of way, with the right, privilege and authority to construct, operate and maintain an electric power line with the right to install, inspect, repair, and replace thereon poles, crossarms, wires, cables, communication equipment, guys, anchors, fixtures and other appurtenances, and to keep the same free from trees, limbs, or foliage, upon and acrosss the following described lands and premises, situate in the County of Eureka, State of Nevada, to-wit:

A portion of the Northeast one-quarter (NE½) of the Southeast one-quarter (SE½) of Section 32, T33N R48E MDMB, Eureka County, Nevada.

Center line of said electric power line to be as follows:

Beginning at a point on the Easterly boundary of the Northeast one-quarter (NE%) of the Southeast one-quarter (SE%) of said Section 32, from which point the East one-quarter (E%) corner of said Section 32 bears North 1°03'07" West 904.4 feet, more or less, and running

Thence, South 69°08' West 600 feet, more or less, to a point on the Southerly boundary of the Northeast one-quarter (NE) of the Southeast one-quarter (SE) of said Section 32.

Grantee, its contractors, agents and employees, shall have the right of ingress to and egress from said right of way and the electric power line thereon for the exercise of the rights herein granted, with the specific understanding the Grantee shall be responsible for any damage to personal property or improvements, suffered by Grantors by reason of the construction, maintenance, or repair of said line.
