DECREE TERMINATING JOINT TENANCIES

ZARILLA PUETT COTTOM, having filed in the office of the Clerk of this Court her petition to establish the death of DAVID H. WEBB, and to terminate the interest of said DAVID H. WEBB in and to the joint tenancies of the hereinafter described property, and it appearing from the Affidavits of Posting on file herein that notice of said hearing has been given as required by law;

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED: That due and legal notice of the

hearing of said Petition has been given; and the matter coming on regularly to be heard this 20th day of NOVEMBER, 1962, and the Petitioner being represented in Court by her attorneys, WRIGHT & EARDLEY, and no one having appeared to contest or oppose said Petition, the Court, after taking the evidence in support of the said Petition, finds all of the allegations of said Petition are true and the prayer thereof ought to be granted.

The Court finds that said DAVID H. WEBB died on December 20, 1960, at Carlin, Nevada; that during the lifetime of said decedent, he and ZARILLA PUETT COTTOM, then known as ZARILLA PUETT WEBB, acquired the hereinafter described real property in the State of Nevada, as joint tenants by Deeds as follows:

- That certain Deed dated November 29, 1957, and recorded November 29, 1957, in Book 73 of Deeds, page 91, office of the Elko County Recorder, Elko, Nevada, which Deed was in reference to the property hereinafter described as Parcels I and II.
- That certain Deed dated April 13, 1959, and recorded April 20, 1959, in Book 25 of Deeds, page 286, office of the Eureka County Recorder, Eureka, Nevada, which Deed was in reference to the property hereinafter described as Parcel III.

The Court further finds that the Petitioner, ZARILLA PUETT COTTOM, has survived the said DAVID H. WEBB, and that neither of said parties during the life time of the decedent, conveyed any interest in said property.

The Court finds that the joint tenancies therein referred to were terminated upon the death of said DAVID H. WEBB, and that all the interest of said joint tenants in the hereinafter property thereby became vested in the surviving joint tenant, ZARILLA PUETT COTTOM.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED, that by reason of the death of said DAVID H. WEBB, all of the right, title, interest and estate of the said DAVID H. WEBB in and to the hereinafter described property, is now vested in ZARILLA PUETT COTTOM.

The property herein referred to is situate in the State of Nevada, and more particularly described as follows, to-wit:

PARCEL I

That certain property situate in the County of Elko, State of Nevada, more particularly described as follows:

Beginning at a point on the Northerly 75 foot right-of-way line of U.S.Highway 40 from which the NW Corner of Section 26, T. 33 N., R. 52 E., MDB&M, as reestablished by Court Order in 1952, bears N. 31°55' W., 2179.0 feet, bieng Corner No. 1; Thence N. 79° 42' E. (by Highway Department bearings N. 79° 32' E.) 50.00 feet along said Northerly right-of-way line to Corner No. 2; Thence N. 0° 36' E., 200.00 feet to

Thence S. 79° 42' W., 50.00 feet to Corner No. 4; Thence S. 0° 36' W., 200.00 feet to Corner No. 1, the point of beginning. Containing 0.225 acres more or less and situated wholly within the SW4NW4 of Said

Section 26, and TOGETHER With all buildings and improvements situate thereon.
