## ORDER CONFIRMING SALE OF REAL AND PERSONAL PROPERTY.

N. J. MORRISON, Administrator With The Will Annexed of the Estate of Mildred P. Ford, deceased, having returned to this Court and filed herein a report of sale of certain real and personal property of said estate; and said; matter coming on regularly this day to be heard; and it appearing to the satisfaction of this Court that due and legal notice of this hearing was given to all persons interested in the manner and form as required by law; that due and legal notice of the sale of said property of the estate was given as required by law by the Clerk of this Court causing notice of the time and place of holding said sale to be posted in three of the most public places in the Town of Eureka, County of Eureka, in which Town and County the property described in said notice is situated, and to be published in The Eureka Sentinel, a newspaper of general circulation in said County, for two weeks, being three successive issues of said paper, next before such sale, in which notice the real property to be sold was described with common certainty, as follows, to wit:
