The above-entitled action having come on regularly for hearing and the court having read the Stipulation heretofore signed by defendants and their attorney, William J. Crowell, and on behalf of the plaintiffs by their attorneys, Goldwater, Taber and Hill, and it appearing to the satisfaction of this Court that Judgment should be entered in favor of the plaintiffs and against the defendants, and each of them, for the sums set forth in such Stipulation, and good cause appearing therefor,

NOW, THERFORE, Judgment be, and the same hereby is, entered in favor of Paramount Film Distributing Corporation, a Delaware corporation, and against Charles P. Leonard and

Carson City Theatre Corporation in the sum of \$1,218.38, together with a reasonable attorneys' fee of \$200.00 and costs of \$6.14.

IT IS FURTHER ORDERED That Judgment be, and the same hereby is entered in favor of METRO-Goldwyn-Mayer, Inc. (formerly known as Loew's Incorporated), a Delaware corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$1,847.95, together with a reasonable attorneys' fee of \$200.00 and costs of \$6.15.

IT IS FURTHER ORDERED That Judgment be, and the same hereby is entered in favor of Twentieth Century-Fox Film Corporation, a Delaware corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$1,147.58, together with a reasonable attorneys' fee of \$100.00 and costs of \$6.14.

IT IS FURTHER ORDERED that Judgment be, and the same hereby is entered in favor of Warner Bros. Pictures Distributing Corporation, a New York corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$1,611.52, together with a reasonable attorneys' fee of \$200.00 and costs of \$6.15.

IT IS FURTHER ORDERED that Judgment be, and the same hereby is entered in favor of Buena Vista Distribution Co., Inc. (formerly known as Buena Vista Film Distribution Co., Inc.), a California corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$1,271.18, together with a reasonable attorneys'fee of \$100.00 and costs of \$6.14.

IT IS FURTHER ORDERED that Judgment be, and the same hereby is, entered in favor of Allied Artists Productions of California, a California corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$321.15 together with a reasonable attorneys' fee of \$67.26 and costs of \$6.14.

IT IS FURTHER ORDERED that Judgment be, and the same hereby is, entered in favor of United Artists Corporation, a Delaware corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$2,274.50, together with a reasonable attorneys' fee of \$200.00 and costs of \$6.15.

IT IS FURTHER ORDERED that Judgment be, and the same hereby is, entered in favor of Columbia Pic tures Corporation, a New York corporation, and against Charles P. Leonard and Carson City Theatre Corporation in the sum of \$1,035.75, together with a reasonable attorneys' fee of \$100.00 and costs of \$6.14.

IT IS FURTHER ORDERED that each of the foregoing Judgments shall bear interest at the rate of five percent (5%) per annum until the principal amounts thereof, attorneys' fees and costs are paid in full.
