QUITCLAIM DEED

THIS INDENTURE, made and entered into this 17th day of July, A.D. 1963, by and between JOSEPH TOGNETTI, also known as JOE TOGNETTI, an unmarried man, of the Town of Eureka, County of Eureka, State of Nevada, the Party of the First Part, and LEE OLINGER and BLANCHE OLINGER, husband and wife, of the same Town, County and State, the Parties of the Second Part,

W I T N E S S E T H:

That the Party of the First Part, for and in consideration of the sum of TEN (\$10.00) dollars, lawful money of the United States of America, to him in hand paid by the Parties of the Second Part, and other good and valuable consideration, the receipt whereof is here-

by acknowledged, does by these presents grant, bargain, sell and quitclaim unto the Parties of the Second Part, and to their heirs and assigns forever, all his right, title and interest in fact or by operation of law in and to the following described real property situate, lying and being in the County of Eureka, State of Nevada, and particularly described as follows, to wit:

Beginning at the Southeast corner, whence the North 1/16 corner between Sections 13 and 14, Township 19 North, Range 53 East, M.D.B. & M., bears South 23° 56' East, 606.67 feet and corner No. 3 of the Old Put Mill Site bears South 67° 58' East, 402.69 feet

Thence South 30° 56' 51" West, 72.19 feet
 Thence North 44° 19' 16" West, 106.58 feet
 Thence North 1° 10' 25" West, 15.96 feet
 Thence North 61° 43' 26" East, 79.47 feet
 Thence South 31° 37' 52" East, 79.80 feet
