**QUITCLAIM DEED**

**THIS INDENTURE**, made this 3rd day of October, A. TO HAVE AND TO HOLD the said premises, together with all and singular the appurtenances unto the said Parties of the Second Part as JOINT-TENANTS and to the survivor of them.
