

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY that the Golden Boy #17 Lode Mining Claim was located by Four Co-Owners, whose post-office address appears below, on the 7th day of November, 1963.

The general course of said lode or vein is Northerly & Southerly.

The claim is situated in the LYNN Mining District EUREKA County, State of Nevada, Section 18, Township 35 North Range 51 East, Mt. Diablo Meridian.

The locator's claim 1400 feet in a northerly direction and 100 feet in a southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: Development work composed of Drill holes at various places on the claim sufficient to fill the requirements of law.

The total cost of such work consisted of at least \$200.00.

The corners and side centers of the claim are located and marked as follows: From the southwest corner, a monument marked Southwest SW Cor. thence in a northerly direction 1500 feet to the northwest corner, a monument marked Northwest NW Cor., thence 300 feet in an easterly direction to the north side center, a monument marked Northside center NSC, thence 300 feet in an easterly direction to the northeast corner, a monument marked Northeast NE Cor., thence 1500 feet in a southerly direction to the southeast corner, a monument marked Southeast SE Cor., thence 300 feet in a westerly direction to the south side center, a monument marked Southside Center SSC, thence 100 feet ^{northerly} to the point of beginning.

Each of the above-described monuments is 4 X 4 Posts.

All location and discovery work necessary to complete this location had been performed by December 10, 1963.
