KNOW ALL MEN BY THESE PRESENTS, that USSRAM EXPLORATION COMPANY, a corporation organized and existing under the laws of the State of Maine and duly qualified to do business in the State of Nevada, the locator and owner of the lode or vein hereinafter described, does hereby certify:

1. The name of the lode or vein is Sunshain No. 14
2. The name of the locator and its Post Office address is:

3. The date of the location of said claim is October 3, 1963.
The said claim is situated in an unorganized mining district in Eureka County, State of Nevada, in the NE $\frac{1}{4}$ of Section 10, Township 32 North, Range 51 East, M.D.M. The northwest corner of said claim is 600 feet due South and 3000 feet due East from the northwest corner of said Section 10, and is identical with the northeast corner of Sunshain No. 10 claim

4. The number of linear feet claimed in length along the course of the vein is 1400 feet in an easterly direction from the point of discovery, and 100 feet in a westerly direction from said point of discovery; the width claimed on each side of the center of the vein is 300 feet; and the general course of the lode or vein, as near as may now be given, is East and West

5. The said Sunshain No. 14 claim and the Sunshain No. 9 and Sunshain No. 10 claims, also located by said Ussram Exploration Company, are contiguous lode mining claims and comprise a group of contiguous claims owned in common by said Ussram Exploration Company. The location work for each and all of said claims in the group consisted of drilling one NX size vertical hole within said Sunshain No. 10 claim at the location and to the depth as follows:

Drill Hole No. S-10-1, situated approximately 90 feet due South and 200 feet due East from the northwest corner of said Sunshain No. 10 drilled from surface to a depth of 96 feet; claim

The said location work cost Ussram Exploration Company in excess of Seven Hundred Dollars (\$ 700.00), and said expenditure will result in tending to advance the exploration of such claims as a group, and the expenditure aggregates more than One Hundred Dollars (\$100.00) for each claim in the group and more than One Hundred Dollars (\$100.00) for each 20.661 acres, or fraction thereof, in the group.

6. The location and description of each corner and side centers, with the markings thereon, are as follows:

The NW corner is marked by a post inscribed N.W. Cor. S. No. 14;
the NE corner is marked by a post inscribed N.E. Cor. S. No. 14;
the SE corner is marked by a post inscribed S.E. Cor. S. No. 14;
the SW corner is marked by a post inscribed S.W. Cor. S. No. 14;
the center of the north side line is marked by a post inscribed N. Side Ctr. S. No. 14;
the center of the south side line is marked by a post inscribed S. Side Ctr. S. No. 14

Each post is $4\frac{1}{2}$ "x5" set 1 foot in the ground and $4\frac{1}{2}$ feet above ground.
