

## LOCATION CERTIFICATE

## LODE MINING CLAIM

This is to certify that the lode mining claim named below was located as described below and that the locator thereof claims by right of the original discovery and location and performance of location work in compliance with the General Mining Laws and the laws of the State of Nevada 1500 linear feet along the vein or lode thereof, together with 300 feet on each side of the middle of said vein along the entire length of the claim at the surface, and all veins, lodes, ledges or deposits within the boundary lines of said claim.

With respect to this location certificate the following facts are presented:

1. The name of the claim is Add No. 37.
2. The name and address of the locator is Nathan E. Salo, P. O. Box 597, Salt Lake City, Utah.
3. The claim is situated in Section 12, Township 35 North, Range 49 East, Mt. Diablo Base and Meridian in Eureka County, State of Nevada.
4. This claim was located on October 3, 1963, and the location notice was posted at the point of discovery on said date and a copy of said notice was recorded on November 12, 1963, in Book "Outside Mining," Page 339, Official Records of Eureka County, Nevada.
5. The locator claims 100 feet northerly and 1400 feet southerly from the point of discovery.
6. Location and discovery work has been performed by November 15, 1963, as follows:

Rotary Drill Hole No. A-2 was drilled on the Add No. 37 to a depth of 55 feet and Rotary Drill Hole No. A-3 was drilled upon Add No. 46 to a depth of 200 feet, which drilling benefits and advances the exploration of Add Nos. 36, 37, 45, 46, 47, 51 and 52 lode mining claims, which are a contiguous group of mining claims located by the undersigned, and which group includes the above named claim.

The total cost of such work was in excess of \$ 200.00.

7. The claim is more particularly described as follows, to wit:

37 Beginning at Corner No. 1, which is also Corner No. 2 of Add No. 44, Corner No. 3 of Add No. 45 and Corner No. 4 of Add No. 36; thence north 1500 feet to Corner No. 2, which is also Corner No. 3 of Add No. 36, Corner No. 4 of Add No. 35 and Corner No. 1 of Add No. 34; thence east 600 feet to Corner No. 3, which is also Corner No. 4 of Add No. 34, Corner No. 1 of Add No. 33, and Corner No. 2 of Add No. 38; thence south 1500 feet to Corner No. 4, which is also Corner No. 1 of Add No. 38, Corner No. 2 of Add No. 43, and Corner No. 3 of Add No. 44; thence west 600 feet to the point of beginning.

The corners of said claim and the side centers are marked with 4 x 4 posts in compliance with Chapter 517.030, Nevada Revised Statutes.
