The East one half of the Northeast quarter of the Northeast quarter, Section 5, Township 31 North, Range 48 East, M.D.B.M., as per Government Survey.

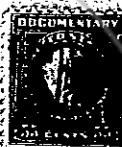
RESERVING THEREFROM an easement of 30 feet along all boundaries for ingress and egress, with power to dedicate.
