

AMENDED LOCATION CERTIFICATE LODE CLAIM

This is to certify that the ALAN No. 16 lode mining claim was located by M. H. White on the 27th day of October, 1961 and recorded on January 17th, 1962 in Book "K" of Outside Mining on page 411 in the Office of the Eureka County Recorder, Eureka, Nevada, and that subsequent thereto on January 18th, 1963 the said claim was assigned to Newmont Exploration Limited as recorded on February 27th, 1963 in Book "26" of Deeds at Page 379 in the Office of the Eureka County Recorder, Eureka, Nevada, and that subsequent thereto on October 18th, 1963 the said claim was amended by Newmont Exploration Limited as recorded on October 21st, 1963 in Book "P" of Outside Mining on page 235 in the Office of the Eureka County Recorder, Eureka, Nevada.

Notice is hereby given that the undersigned Newmont Exploration Limited as assignee and claimant of the said ALAN No. 16 lode mining claim and preserving all rights under the said original location thereof does hereby further amend the description of this claim, supplementing the information contained in the original certificate and the amended certificate as recorded in the manner hereinafter set forth. The size, outline, and field position of the claim remains as originally recorded.

The claim is situated in the Lynn Mining District, Eureka County, Nevada; its discovery monument is located approximately north $77\frac{1}{2}^{\circ}$ west twenty hundred and eighty-two (2082) feet from the east quarter corner of Section 14, Township 35 North, Range 50 East, Mount Diablo Base and Meridian.

The general course of the lode is north and south.

The claim extends 200 feet in a south direction and 1300 feet in a north direction from the discovery monument and 300 feet on each side of the center line of the lode along the full length of the claim. Mineral of value has been discovered in place in a lode in a bulldozer trench, the easterly end of which bears approximately south $72\frac{1}{2}^{\circ}$ east, a distance of 140 feet from the said discovery monument. The said trench bears approximately south $70\frac{3}{4}^{\circ}$ west for 318 feet and thence south $56\frac{3}{4}^{\circ}$ west for 300 feet from the said easterly end.

The corners and side centers of this claim are located and marked as follows: Beginning at the northwest corner, a 4"x4"x4½" wood post marked NW COR. Alan No. 16; thence south 750 feet, west side center, a 4"x4"x4½" wood post marked W S/C Alan No. 16, 1500 feet to the southwest corner, a 4"x4"x4½" wood post marked SW COR. Alan No. 16; thence east 600 feet to the southeast corner, a 4"x4"x4½" wood post marked SE COR. Alan No. 16; thence north 750 feet, east side center, a 4"x4"x4½" wood post marked E S/C Alan No. 16, 1500 feet to the northeast corner, a 4"x4"x4½" wood post marked NE COR. Alan No. 16; thence west 600 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the east side line of the Alan No. 23 claim; the north end line is contiguous with the south end line of the Alan No. 28 claim; the east side line is contiguous with the west side line of the Alan No. 15 claim; the south end line is contiguous with the north end line of the Alan No. 8 claim.
