

LOCATION CERTIFICATE
LODE MINING CLAIM

This is to certify that the lode mining claim named below was located as described below and that the locator thereof claims by right of the original discovery and location and performance of location work in compliance with the general mining laws and the laws of the State of Nevada 1,500 linear feet along the vein or lode thereof together with 300 feet on each side of the middle of said vein along the entire length of the claim at the surface and all veins, lodes, ledges or deposits within the boundary lines of said claim.

With respect to this Location Certificate the following facts are presented:

1. The name of the claim is Ante 4.
2. The name and address of the locator is George H. Dille, P. O. Box 597, Salt Lake City, Utah.
3. The claim is situated in Section 36, Township 36 North, Range 49 East, Mount Diablo Base and Meridian, in Eureka County, State of Nevada.
4. This claim was located on December 20, 1963, and the location notice was posted at the point of discovery on said date and a copy of said notice was recorded on December 26, 1963, in Book 2, Page 225, official records of Eureka County, Nevada.

5. The locator claims 750 feet northerly and 750 feet southerly from the point of discovery.

6. Location and discovery work has been performed by February 24, 1964, as follows:

Rotary Drill Hole No. A-10 was drilled on Ante 4 to a depth of 120 feet, which drilling benefits and advances the exploration of Ante 2, 3, 4, 5, 11, 12, 13, 14, 15 and 16 lode mining claims which are a contiguous group of claims located by the undersigned and which group includes the above named claim.

The total cost of such work was in excess of \$1,000.00.

7. The claim is more particularly described as follows, to-wit:

Beginning at Corner No. 1, which is also Corner No. 2 of Ante 13, Corner No. 3 of Ante 12, and Corner No. 4 of Ante 5, thence north 1500 feet to Corner No. 2, which is also Corner No. 3 of Ante 5, Corner No. 4 of Fan-Tan, and Corner No. 1 of Pan, thence east 600 feet to Corner No. 3, which is also Corner No. 4 of Pan, Corner No. 1 of Roulette, and Corner No. 2 of Ante 3, thence south 1500 feet to Corner No. 4, which is also Corner No. 1 of Ante 3, Corner No. 2 of Ante 14 and Corner No. 3 of Ante 13, thence west 600 feet to the point of beginning.

The corners of said claim and side centers are marked with 4 x 4 posts in compliance with Chapter 517.030, Nevada Revised Statutes.
