WITNESSETH:

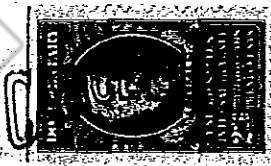

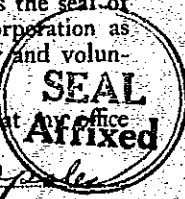
