

LOCATION CERTIFICATE

LODE MINING CLAIM

This is to certify that the lode mining claim named below was located as described below and that the locator thereof claims by right of the original discovery and location and performance of location work in compliance with the General Mining Laws and the laws of the State of Nevada, 1500 linear feet along the vein or lode thereof, together with 300 feet on each side of the middle of said vein along the entire length of the claim at the surface and all veins, lodes, ledges or deposits and surface ground within the boundary lines of said claim.

With respect to this location certificate the following facts are presented:

1. The name of the claim is Polaris No. 20.
2. The name and address of the locator is Robert L. Akright, P. O. Box 597, Salt Lake City, Utah.
3. The claim is situated in Sections 24 and 25, Township 36 North, Range 49 East, Mt. Diablo Base and Meridian in the Lynn Mining District, Eureka County, State of Nevada.
4. This claim was located on February 25, 1964, and the location notice was posted at the point of discovery on said date.
5. The locator claims 100 feet northwest and 1400 feet southeast from the point of discovery.
6. Location and discovery work has been performed

by March 20, 1964, as follows: Preparation of a drill site and drilling of Rotary Drill Hole No. A-11, on the Polaris No. 20 lode mining claim to a depth of 230 feet, which drilling benefits and advances the exploration of Polaris Nos. 19, 20, 21 and 22, lode mining claims, which are a contiguous group of mining claims located by the undersigned and which group includes the above named claim.

The total cost of such work was in excess of \$400.00.

7. This claim is more particularly described as follows, to-wit:

Beginning at Corner No. 1, which is also a point on the north side line of Polaris No. 22 and Corner No. 4 of Polaris No. 21, thence northeast 600 feet to Corner No. 2 which is also Corner No. 3 of Polaris No. 21, thence southeast 1500 feet to Corner No. 3, thence southwest 600 feet to Corner No. 4, thence northwest 1500 feet to the point of beginning.

8. The corners of said claim and the side centers are marked with 4 x 4 posts in compliance with Chapter 517.030, Nevada Revised Statutes.
