The Court further finds that the Movant, ANGEL CAROL BERVILLER, is the only person interested in the subject matter of this motion, and accordingly, no notice is required.

The Court further finds that THOMAS O. BATH, the late executor of the estate of the Decedent above-named, was, by order of this Court, made and entered on February 18, 1955, commanded to convey to ANGEL D. FLORIO, as guardian of the estate of ANGEL CAROL FLORIO, a minor, the necessary muniments of title to said property; that the said executor, as of the date of his death, September 25, 1964, had not complied with said order.

The Court further finds that ANGEL CAROL BERVILLER (formerly ANGEL CAROL FLORIO) has heretofore attained the full age of majority; that her guardianship estate was closed and terminated and her guardian released and discharged on the 30th day of April, 1963.

The Court concludes as a matter of law that ANGEL CAROL RERVILLER is entitled to the judgment sought by her said motion in order to perfect and clear the official record of her title to said property.

THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED: That the Decedent's estate above-named he, and the same is hereby, divested of title to said property, and that all right, title and interest in and to said property be, and the same is hereby, vested in ANGEL CAROL BERVILLER (formerly ANGEL CAROL FLORIO).

It is further ordered that the convoyance herein ordered shall relate back, nuncepro tunc to the 1st day of May, 1963.
