

RECONVEYANCE OF TRUST PROPERTY.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, all the indebtedness secured to be paid by the Deed of Trust executed by ANGELO C. TOGNONI and EMILIA S. TOGNONI, husband and wife, and THOMAS C. JOHNSTON and CECILE T. TOGNONI and EMILIA S. TOGNONI, husband and wife, and THOMAS C. JOHNSTON and CECILE T. JOHNSTON, husband and wife, all the estate and interest derived to us, or either and all of us by and through said Deed of Trust in and to the following described real property situate in the Town of Eureka, County of Eureka, State of Nevada, to-wit:

Lots eighteen, nineteen, twenty, twenty-one, and twenty-two of block twenty-one. Beginning at the NE Corner of lot seventeen in block twenty-one, thence S. $17^{\circ} 50'$ E., a distance of 37.5 ft. to a point on the east end line of lot sixteen, thence S. $72^{\circ} 10'$ W. and parallel with the south side line of lot sixteen, a distance of 48.58 ft. to a point in lots sixteen, thence N. $17^{\circ} 50'$ W. a distance of
