WITNESSETH:

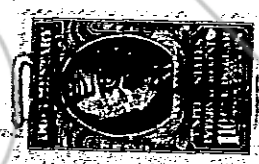

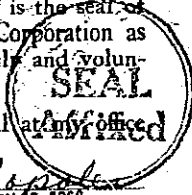
