THIS INDENTURE, made this 17<sup>th</sup> day of August, A. D. 1964, by and between MARTIN FERGUSON, an unmarried man, of the Town of Eureka, County of Eureka, State of Nevada, the Party of the First Part, and JOHN F. SEXTON and MARGARET R. SEXTON, his wife, of Battle Mountain, County of Lander, State of Nevada, the Parties of the Second Part,

W I T N E S S E T H:

That the said party of the first part, for and in consideration of the sum of TEN (\$10.00) Dollars, lawful money of the United States of America, to him in hand paid by the parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the parties of the second part, not as tenants in common, but as JOINT-TENANTS with the right of survivorship, and to their heirs and assigns forever, all those certain lots, pieces or parcels of land situate, lying and being in the Town of Palisade, County of Eureka, State of Nevada, and particularly described as follows, to wit:
