

GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made the girl day of Jerman, 1964, between HAZEL L. HANSON, a widow, party of the first part and hereinafter referred to as "Grantor", and JAMES ITHURRALDE and MARY JEAN ITHURRALDE, husband and wife; parties of the second part and hereinafter referred to as "Grantees";

WITNESSETH

That the said Grantor, for and in consideration of the aum of One Dollar (\$1.00), lawful money of the United States of America, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does hereby grant, bargain and sell, unto said Grantees and to their heirs and assigns forever, the following described lots, pieces or parcels of land situate; lying and being in the County of Eureka in State of Nevaday and bounded and particularly described as follows, to-wit:

Together with two pumps, one disc, miscellaneous galvanized roofing, lumber, and fencing materials, and one Buda Engine.
