JOINT TENANCY DEED

AGREEMENT

Alice T. Crabtree, as her separate property, Florence T. Moore, as her separate property, and Louise T. Youngman, as her separate property, who own as joint tenants an undivided one-fourth interest in and to the real property described below, hereby grant to Joseph L. Rand and Ellen M. Rand, husband and wife, as joint tenants, with right of survivorship, said undivided one-fourth interest, except for a reservation of oil and other mineral rights as stated below, in and to that certain real property situate, lying and being in the County of Eureka, State of Nevada, described as follows:

Section 11: Lots 2, 3 and 4, and NE $\frac{1}{4}$ SW $\frac{1}{4}$;
 Section 14: Lots 2, 6 and 7, and SW $\frac{1}{4}$ NE $\frac{1}{4}$;
 Section 21: SE $\frac{1}{4}$ NE $\frac{1}{4}$; and N $\frac{1}{2}$ SE $\frac{1}{4}$

Expressly reserving, however, to Florence T. Moore, as her separate property, an undivided one-eighth interest, and to Louise T. Youngman, as her separate property, an undivided one-eighth interest, in and to all oil, gas, other hydro-carbon substances and other minerals in and under and that may be produced from said real property, with the right of ingress and egress to drill for and remove the same.

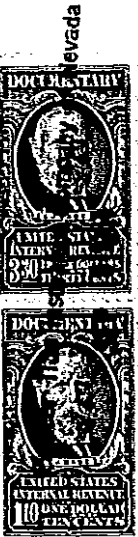
Each of the undersigned hereby expressly covenants and warrants to the grantees, above named, that her interest in said real property hereby granted is her separate property.
