# The United States of America

To all to whom these presents shall come, Greeting:

WHEREAS, a Certificate of the Land Office at Reno, Nevada,  
is now deposited in the Bureau of Land Management, whereby it appears that full payment has  
been made by the claimant, Edwin Carl Bishop,  
according to the provisions of the Act of Congress approved March 3, 1877 (19 Stat. 377), as amended  
by the Act of March 3, 1891 (26 Stat. 1096), for the following described land:

Mount Diablo Meridian, Nevada

T. 20 N., R. 53 E.,  
Sec. 21, Lots 3, 4, 5, 6, 12, 13, 14, 15.

The area described contains 328.23 acres,  
according to the Official Plat of the Survey of the said Land, on file in the Bureau of Land Management:

Now Know Ye, That the UNITED STATES OF AMERICA, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, HAS GIVEN AND GRANTED, and by these presents Does Give AND GRANT unto the said claimant and to the heirs of the said claimant the tract above described; To HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said claimant and to the heirs and assigns of the said claimant forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the lands hereby granted, a right-of-way thereon for ditches or canals constructed by the authority of the United States.

Excepting and reserving also, to the United States all the oil and gas in the land so patented, and to it or persons authorized by it, the right to prospect for, mine, and remove such deposits from the same upon compliance with the conditions and subject to the provisions and limitations of the Act of July 17, 1914 (38 Stat. 509).

There is also reserved a right-of-way for a Federal Aid Highway under 23 U.S.C. 317.

In TESTIMONY WHEREOF, the undersigned authorized officer of the Bureau of Land Management, in accordance with the provisions of the Act of June 17, 1948 (62 Stat. 476), has, in the name of the United States, caused these letters to be made Patent, and the Seal of the Bureau to be hereunto affixed.

GIVEN under my hand, in Reno, Nevada, the SIXTEENTH day of SEPTEMBER in the year of our Lord one thousand nine hundred and SIXTY-FOUR, and of the Independence of the United States the one hundred and EIGHTY-NINTH.
