duly recorded in the office of the County Recorder in the County of EUREKA State of Nevada, in accordance with the above-mentioned mining laws.

That there is a total of 35 claims and the undersigned as co-owners were required to make an annual expenditure of at least \$100.00 per claim per year to hold said respective claims for the years 1959, 1960, 1961, 1962 and 1963. That Ray Nelson claimed a 1/3 interest in said claims for the years 1959, 1960, 1961, 1962 and 1963 and by written agreement between Ray Nelson and the undersigned co-owners, which agreement was dated June 14, 1963, it was agreed that said Ray Nelson owed the said co-owners the sum of \$3000.00 for his share of said assessment work for said years. In said agreement it was further agreed that said Ray Nelson was responsible and obligated to perform one third of the annual assessment work on said claims for the year 1964. That Ray Nelson did not perform said work and the undersigned co-owners were required to do said work on the last 10 mines claims and to make an expenditure of at least \$1000.00 to hold said 10 claims. That Ray Nelson is obligated to pay one third thereof or a sum of \$333.33.

That, in fact, Ray Nelson has not paid any of said sums or any part thereof, either the above mentioned \$3000.00 or the said \$333.33 and therefore owes to the undersigned co-owners and is obligated to pay to them the total sum of \$3,333.33, which sum is now due and owing.

You are hereby notified that if, within ninety (90) days after this notice by publication or personal service upon you, you fail or refuse to contribute your portion of such expenditures in the sum of \$3,333.33 as set forth above, and pay the same to the UNDERSIGNED who actually made such expenditures to hold said claims, then your interests, if any, in the above-described Mining Claims shall be FORFEITED to and become the property of the UNDERSIGNED Co-Owners under the provisions of U. 
