THIS MEMORANDUM OF LEASE, made and executed in duplicate as of . the /d day of Hutust , 1964, by and between SOUTHERN PACIFIC COMPANY, a Delaware corporation, hereinafter called "Lessor", and NORTHERN PLAINS PETROLEUM CO., a Nevada corporation, hereinafter called "Lessee".

WITNESSETH:

Lessor, for and in consideration of the covenants and agreements to be kept and performed by Lessee, as contained in that certain mining lease between Lessor and Lessee of even date herewith, does by these presents lease unto Lessee the following property situated in the Counties of Lander and Eureka, State of Nevada, more particularly described on Exhibit "A" attached hereto and made a part hereof.

For the sole and exclusive purpose of examining, searching and testing for, opening and operating mines, to drill for and produce steam and thermal energy and extract, reduce, treat, sell and ship any and all steam, thermal energy, minerals in solution or suspension. and all minerals and mineral-bearing materials contained therein and concentrates thereof, excepting and reserving all oil, petroleum, natural gas and other hydrocarbons, and all rights thereto.

Also reserving unto Lessor, its successors and assigns, rights of way for existing and any future additional pipe, signal, telegraph, telephone, communication and power transmission lines and facilities, ditches, flumes, roads, trails and tracks in, over, upon or adjacent to said property and the right to use such land for any and all purposes consistent with or which shall not interfere with the right of the Lessee to use said land for the purposes herein leased, including the right to enter on the land and explore for, develop and remove the reserved oil, petroleum, natural gas, and other hydrocarbon substances. Lessee shall have the right to make all such use of the lands and

thereon or therein to place, erect, construct, maintain and use all such buildings, engines, machinery and other equipment and facilities and make all such excavations, openings, ditches, drains and other improvements as may, in opinion of Lessee, be necessary or useful for the purposes aforesaid, or for any subsidiary purpose connected therewith.

- The term of this lease shall be, subject to the strict performance of the covenants and agreements contained herein, for five years and so long thereafter as Lessee carries on active mining or exploration, as defined in said mining lease, on the leased premises, but shall not exceed more than fifty (50) years from the date hereof.
- The rights and obligations of the parties with respect to this lease of the land described herein and the use thereof are all set forth in mining lease of even date herewith between the parties hereto. This memorandum of mining lease and said mining lease shall always be considered and construed together, and they shall be deemed jointly to constitute but one lease covering the rights and liabilities of the parties, reference to said mining lease being nereby made for greater particularity.

TO HAVE AND TO HOLD THE SAME, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining, for the purposes and upon the terms set forth in said mining lease.
